

Objectives	<ul> <li>SKAGEN Focus is an actively managed equity fund with a global investment mandate.</li> <li>The fund's objective is to provide investors with the best possible long-term risk adjusted return, through an actively managed portfolio of global shares.</li> <li>The fund's strategy is to invest in very select, undervalued, high quality companies with clear catalysts for revaluation. The portfolio may hold companies across the market capitalisation spectrum, with the majority of its exposure to small and mid-cap companies.</li> <li>In order to reduce risk, the fund seeks to maintain a sensible composition of companies by identifying fundamental risk factors. These risk factors are measured, monitored and balanced against each other.</li> <li>The fund deploys an ESG integration strategy to support the investment mandate. The product is therefore categorized as Article 8 as per the Sustainable Finance Disclosure Regulation. # What are the risks and what could I get in return?

## **Risk indicator**



This risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you might get back less. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets. We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level. Other risks materially relevant to the PRIIP not included in the summary risk indicator: Event risk, liquidity risk, operational risk, counterparty risk, derivatives risk and currency risk. If the fund invests in securities in a currency other than the fund's base currency, the value is affected by changes in the exchange rate. In addition, the value of your payout may be affected if your local currency is different from the fund's currency. # What are the costs?

#### Costs over time

# How long should I hold it and can I take money out early?

#### Recommended holding period: 5 years

This fund has no required minimum holding period. You may sell earlier, but the product is not suitable for investors planning to redeem their units within 5 years. Subscription and redemption of fund units can normally take place on all Norwegian business days, with certain exceptions. No additional costs will be incurred if you redeem before the recommended holding period.
